Chair's Report

In my second year as Chair of Volunteer Task Force (VTF), I am very pleased to report upon the financial year 2014/15, a year of growth and change for VTF.

Over this past year the Board has taken steps to ensure VTF is positioned to further innovate and grow. In a range of ways we have begun a positive transformation to equip VTF to continue to deliver high quality services. With a strong focus on the governance of the organisation, the Board has established Board committees in the areas of Strategy, Finance and Risk Management, Governance, and Remuneration and Nomination. These committees have been able to address strategic topics in more depth and identify opportunities for Board consideration. We have reviewed how we provide and develop our services and established new ways of engaging and better servicing our clients. In 2014/15 we achieved outstanding results of 96% of our HACC target, which can be attributed to the direction and dedication of the Board and the management team and the commitment of the VTF workforce as a whole.

We appointed a new CEO, Kath Snell, who has been with VTF since 2006. Kath first began at VTF as a volunteer and then as a staff member who subsequently worked her way through the ranks. The CEO appointment is a part of the Board's endeavour to strengthen and grow the organisation

and I take this opportunity to thank Kath for her vision and leadership.

Volunteering is at the heart of all we do at VTF and I thank my fellow Board Directors, who also devote their time as volunteers. In the financial year 2014/15 the Board welcomed two



new members, Craig Adam and Michael Ferguson, who have brought valuable skill sets and experience to the Board that complement those of our other Board Directors: Monica Juricev, John Van Dieren, Rose Blight, Martin Michalik, Paul Vivian, Megan Paull and Tony Richards. The commitment of the Board and their expert guidance is assisting VTF to make even greater achievements.

Every day we are working to support independent living in the community. As we embark on a new five-year plan, we enter a new strategic phase of the organisation and the Board looks forward to seeing VTF further grow and flourish. Chief Executive Officer's Report

Welcome to the 2015 annual report. It is a privilege to present this report as a testimony to all the work done and achievements attained at Volunteer Task Force (VTF), in this, my first official year as CEO. It has been an active and full year for VTF with strategic plans coming to fruition and achieving our biggest target to date in terms of service delivery.

This, my ninth year with the organisation, has echoed my thinking that each year seems to go a little faster than the last, so it's vital to start planning early to make sure we can achieve all we possibly can in each financial year. This has certainly happened for 2014-15 and our results are a testament to an active Board, an engaged and skilled management team and a workforce of paid staff and volunteers whose focus and priority is the provision of quality service.

In this financial year we saw a number of internal promotions in the management team, my own movement from Senior Manager to Acting CEO to CEO being one example and also Donna Di Bartolomeo successfully gaining the position of Senior Manager after previously sitting in the role of Manager Operations and Projects. Internal recognition at VTF is a reflection of our commitment to staff development and opportunities. Staff across the organisation have experienced similar investment with their movement to more senior positions across departments including the creation of Booking Assistants roles to support the administration of service delivery and a new position of Gardening and Special Projects Advisor which was filled by long serving and deserving staff member Andy Harold. This role will further develop our Water Wise and other sustainable gardening projects.

The theme this year has very much been one of growth and forward planning. We stand solidly on a firm and robust framework. The spirit of VTF still runs through the purpose, ethics and culture of the organisation and with this strength beneath our feet, we can focus on the future development of the organisation.

We have concentrated on the geographical growth of VTF in order to better service clients in an area of need in the East. In doing this we have developed a relationship with not-forprofit Police Communities Youth Centres (PCYC) and early in the new financial year will be



opening a depot in Midland, which is a shared facility with PCYC. We very much look forward to furthering our links next year and growing our organisations' synergies.

Our teams have delivered more services working with more clients, staff and volunteers this year than ever before. VTF continues to be a place of pride in our work, devotion to our cause and welcome to new members of the workforce, clients, partners and ideas.

As the sector embarks on a future of uncertainty in terms of reforms, funding and administration, VTF remains strong, optimistic and enthusiastic. Before us lie opportunities for continued high quality service, additional openings for volunteers and growth in new areas.

As I reflect on the year, I do so with warmth, pride and gratitude to be working with a team of skilled, devoted and earnest colleagues. My thanks for the enormous effort and well deserved success goes to the diligent staff, the selfless volunteers and the professional Board that continues to direct and support VTF. KRA 1 Maintain high quality service delivery

Client Services




Figure 1 New client referrals by service and by month 2014/15

VTF works within the WA Assessment Framework to deliver client-centred services across the greater Perth metropolitan area. Referrals are made to VTF through the Regional Assessment Services (RAS). In 2014/15 VTF received more than 1372 new referrals for services and more than 4,000 reviews. The increase in referrals, in particular for transport in the second half of the year, was made possible with welcomed growth funding from the Department of Health in January (see figure 1). This made for a busy and interesting year for the Client Services team who work closely with RAS across the four Department of Health metropolitan regions.

The RAS/VTF relationship is a valued and important one that ensures a seamless and positive client experience and journey through the care continuum. Communication is integral to the success of this partnership. While the communication is largely electronic and over the phone, the Community West RAS and Service Provider workshops held across the regions in June provided the opportunity for informal networking and put faces to names. VTF would like to acknowledge and thank the RAS with whom we work across the Perth metropolitan area.

Domestic Assistance

Supporting people in the home with everyday household tasks that they have difficulty managing themselves, while comprising a small part of VTF's overall endeavour, is nevertheless an important strategy in supporting a person's independence and their ability to remain living at home.

Over the past year an emphasis has been on building the VTF Support worker team and structuring staff and reporting lines to maximise the resources available and to gain greater synergy between our Domestic Assistance and Social Support programs. A key task of the newly created Domestic Assistance Social Support Supervisor role was the recruitment of new staff and the development of the existing work force. In 2014/15 four support workers were welcomed to VTF, bringing the team to 14, many of whom also now provide social support to their clients. In 2014/15 this dedicated team assisted more than 243 clients across the metropolitan area providing 7299.27 hours of Domestic Assistance support.




Figure 2 Referrals by service type 2014/15

VTF also acknowledges the support of Tilly's Home Helpers who have assisted in ensuring service reach and continuity through the year.

Social Support

In response to the prevalence and risk of social isolation among older people and the detrimental impact this can have on their health and well-being, VTF Social Support programs are designed to build friendships and to encourage social and physical participation in the community. Activities include home visiting, support with shopping or attending appointments, group outings to events or attractions in the community and Supporting Togetherness and Encouraging Participation (STEPs), the eight-weekly exercise and wellbeing programs. Volunteers are an integral part of these programs providing 25% of the total service hours .

Changes were made to our outings activities this year with a move to a more local focus to reduce the amount of travelling and to increase participation and connection with the local community. Some of the places visited included the Botanical Gardens, Leapfrogs café, Fremantle prison, Kings Park and Sculpture by the Sea.

The STEPs program (previously known as Step Into Life) was held in six locations across the metro area including Padbury, Balga, Forrestfield, Rivervale, Piney Lakes and Safety Bay. Activities such as Tai Chai, Yoga, Qigong and Line dancing are adapted to consider individual capabilities so that everyone is able to participate and progress in their own way. Attendance is particularly strong in the north and eastern areas with positive feedback on the difference that participation in these activities has made on clients' lives.

"I joined the STEP program at Forrestfield late last year after attending the falls clinic at Midland hospital. I find the exercises very beneficial to my shakiness and balance and it is most enjoyable to be doing them with such a lovely group of people" (STEPs participant)

Our aim for the next 12 months will be to build similar positive experiences and outcomes in the metro south west where participation has not been as high.

Client Focus groups

Client focus groups are held each year to gain input and feedback from people who receive VTF services. The client focus groups, together with our other avenues for feedback, assist us in understanding what works well, what the gaps may be and where improvements could be made.

Over all, participants from this year's focus groups in Safety Bay and Padbury were very happy with services provided by staff and volunteers and were very appreciative of the help that they received. They felt that they had choice about their services and valued having their opinions heard. Affordability was a common reason given for the value of the service, as was the friendliness and helpfulness of staff and volunteers.

Suggestions for improvement that were found, particularly around communication and the way in which information is disseminated, will be considered in the planning for 2015/16. Participants enjoyed the social aspect of the day and said that they would like to meet more often. Options for doing so will be further explored within our Social Support program.

Curtin Evaluation of Transport and Home Maintenance

Last year it was reported that VTF had partnered with Curtin University on a project to research the enablers and barriers to the Transport and Home Maintenance services for VTF clients. Pre- and post- test interviews were conducted in 2013/14 with clients who were accessing VTF services for the first time. The key findings of this research, released in November 2014, provided evidence that VTF services were successful in helping people to remain independent at home. While both services were found to have a positive impact on safety and social interaction, they also had a significant impact on emotional wellbeing. The gardening service was found to be very important to some participants as they considered their garden to be a reflection of who they are, while transport clients reported that their emotional wellbeing was profoundly impacted by the loss of a client's driver's licence, loss of private transport, or being unable to physically access public transport. These and other findings of this research highlight the value of having and developing ongoing evaluation systems to build services that are truly person-centred and VTF would like to thank the research team at Curtin University for their caring and professional approach.

Gardening and Home Maintenance

VTF continues to expand and review the Gardening and Home Maintenance service to ensure we are meeting the changing needs of people referred to VTF for this service. This year as part of VTF's growth funding, we are offering an Outdoor Maintenance service to those people with smaller dwellings who required small tasks inside and outside the home to assist them to live in a safe environment. We have also partnered with PCYC to establish a new depot in Midland which will open in August 2015.

This year the Health Department contracted us to deliver more than 72,932 hours of Gardening services and almost 3703 hours of Home Maintenance services across the Perth metropolitan area. VTF was able to deliver 97% of contract providing services to more than 4141 clients.

Our Water Wise program continues to grow and achieve great outcomes. In April 2015 VTF appointed a Gardening and Special Projects Advisor, Andy Harold. Andy provides support and mentoring to the Water Wise Champions to build on our Water Wise program using sustainability principles. VTF has recently gained certification for the Water Wise program with the Landscape Industries Association of WA (LIAWA). Two of our Gardening depots have already completed this training and gained certification with LIAWA, and our other two depots are scheduled to complete the training in September this year.

Water Wise gardens consider people's needs in a holistic way. Through consultation, Water Wise champions work with clients involving them in all aspects of the Water Wise remodel. This ensures that the support delivered is in partnership with the client and enables clients to achieve wellbeing and quality of life to the fullest extent. Clients gain many benefits from Water Wise gardens such as increased self-esteem, pride and dignity, less reliance on family, eliminating potential safety risks, reducing garden space so that clients can often hand water, reducing water bills and reducing the need to have a regular Gardening service.

We continually receive feedback from clients informing us that their Water Wise garden has made such a difference to their lives.

"I had a water wise remodel to the front of my garden last year and I am now doing the back area. The Safety Bay Gardening Team are amazing. I have received so many comments about my garden and the birds are now coming in abundance. I tell everyone about the wonderful work that VTF do. I could start a small business charging an entry fee as so many people comment on my beautiful garden".

"We recently had our front garden remodelled, the soil improved and was mulched by a team of very dedicated volunteers - and I just wanted to write and let Volunteer Task Force know how much we appreciated their efforts. I had to go out to an eye clinic appointment before they had completed the garden, and when I came home I actually cried - it looked so beautiful! I still keep going out to admire their work. Before Volunteer Task Force started doing our garden it was a mess with weeds and overgrown shrubs, and made us feel quite depressed to look at it. My husband and I both have chronic illnesses that restrict us from doing the things we love - like gardening, so having Task Force come and help us has been fabulous. Please give our heartfelt thanks to all those involved."

This year VTF completed 400 Water Wise assessments and 285 Water Wise remodels; 196 clients received a follow-up Water Wise check.

VTF has built strong partnerships with local councils, nurseries, businesses and organisations specialising in sustainability principles. We would like to thank all of our existing partners for their ongoing contribution and commitment to this program: Carramar Nursery; Lulfwits; City of Kwinana; Carlisle Soil World; the Forever Project-Chris Ferreira; the City of Joondalup; the City of Wanneroo; City of South Perth; and VTF also welcome a new partner, the Landscape Industries Association of WA.

As evidenced by the Curtin University research findings, VTF has successfully delivered services that have successfully delivered services that had assisted clients to remain independent and living in their own home. There was also a positive impact on clients' emotional wellbeing, safety and social interaction.

Commendations from the research:

- The majority of participants felt happier, relieved, comfortable, less anxious, less embarrassed, and did not have to worry about their garden being untidy and out of control after using the Gardening service.
- The Gardening service was very important to some participants as they considered their garden a reflection of who they are. Compliments from neighbours had increased their self-esteem, pride and dignity.

In some cases the service reduced the need to rely on family and identified and eliminated potential safety risks. The Gardening and Home Maintenance Service did not seem to have a major impact on the participants' physical health but they were relieved there was a backup. Falls risks were reduced with clients being provided with safer and more secure homes and with a clear view inside and out.

Our Home Maintenance service continues to grow. We have four Home Maintenance Coordinators, who, with support from volunteers, cover the metropolitan region fixing taps and tiles, changing light globes, putting up pictures, turning mattresses, cleaning ceiling fans and a whole realm of other jobs that support the client to live safely and happily at home. As part of the growth funding VTF has introduced a Gardening and Home Maintenance service in the South Metro region for those people living in smaller dwellings such as villas, units and duplexes who do not require a regular ongoing service. This service is provided by one staff member and a volunteer who support by assisting with minor home repairs and yard work with a focus on safety and access in and around the home.

Volunteering in Gardening and Home Maintenance is again very popular with corporate groups, school groups and individual volunteers across all of the depots. During the past 12 months we have had a number of enthusiastic school groups join us in the Gardening program, assisting also with the Water Wise Gardening program. Morley Senior High School, Scotch College, Warnbro Community High School, Como Secondary College, Emmanuel Catholic College, Tranby College, St Stephens, Central TAFE and Cannington Community Education Support Centre are just a few of the schools that have helped our staff to maintain clients' gardens and yards. We have enjoyed having all the students participate in our teams.

We have again this year welcomed back many corporate groups and also new companies to volunteering. We value the enthusiasm, eagerness and professionalism of our corporate teams who are always keen to make a difference. Some of the groups we have worked with are: Ajilon Australia; Assetivity; Cummins; Galvin Engineering; and Mirvac. Many new individual volunteers have joined VTF this year and continue to work with our large number of regular volunteers who have been coming for many years. All of our volunteers have helped by providing many hours of volunteering to the Gardening and Home Maintenance service. We value the loyalty and commitment of all of our volunteers.

Transport

Transport continues to be an area of significant service growth for VTF.

In 2014-15 the Transport Service has continued to assist an increasing number of clients to travel to and from specialist, hospital and allied health appointments, and for shopping, social activities and community events. The Transport Service makes possible crucial health care appointments and social activities that enable clients to retain their independence for longer and to stay connected to their community.

In 2014–15 VTF was able to deliver 3,200 additional trips across the Metropolitan Area which was assisted by HACC funding. These trips resulted in the delivery of more than 81,700 Transport Services across 2014-15, meeting 100% of our HACC Service. This performance highlights the essential service that Transport provides to HACC clients, with more than 2600 clients receiving services in 2014-15.


By utilising taxis VTF is able to provide transport 24 hours a day, 7 days a week (including public holidays) and offers a flexible and responsive service to clients.

A strong and valued partnership is maintained with Swan Taxis, Black & White Cabs and Mandurah Taxis. Their services and ongoing support are greatly appreciated in providing this essential community service.

Volunteer drivers continue to complement our service, along with our paid drivers who utilise VTF 'people mover' vehicles. This allows VTF to provide transport services to clients who may require individual assistance such as providing a little extra time to get in and out of the vehicle or to their homes, in addition to assisting our Social Support team with their transport needs.

Many VTF clients have medical appointments at hospitals and large medical campuses can be a daunting experience for them.

During the year VTF participated in the new Fiona Stanley Hospital services induction process to become familiar with transport



During 2014-15, VTF's Transport scheduling service improved the overall efficiency of its Transport batching capability whereby multiple clients were able to be transported on a single vehicle 'hire'. By far the largest volume of transport journeys are provided by taxi services.VTF's Transport Service is coordinated by VTF staff and volunteers, access requirements to this large state of the art medical facility.

Teams supporting the Transport coordination service underwent a significant organisation restructure in 2013-14, and this year made an exceptional effort to bed in the changes in a way that was seamless to clients. Their adaptability, problems solving ability and initiative are applauded. We also welcomed a number of new volunteer drivers who gave generously of their time to assist our Transport Service.

To accommodate changes in the Aged Care sector and increased demand for transport, VTF continually monitors and reviews the model for delivery of Transport Services. This ensures that VTF is able to continue to meet the needs of clients.

VTF acknowledges the incredible effort and dedication of our staff and volunteers, who continue to support HACC clients by contributing their time, skills and enthusiasm to support delivery of the Transport Service.

KRA 2 Maintain and enhance a positive VTF culture to deliver our services

VTF is committed to achieving the highest possible standard of workplace health and safety in all areas including for its clients, volunteers, contractors and visitors.

As part of this ongoing commitment the OSH Manager attended intensive training through the Chamber of Commerce and Industries to gain Certification in Workplace Health and Safety.

This training assisted in the review and update of OSH policies and procedures and the introduction of new safety strategies such as "Spill Kits" containing Personal Protective Equipment which were placed in all vehicles transporting clients. These kits were supplied so that staff and volunteers were able to safely and quickly deal with any accidents or included Flu Vaccinations and Molescan consultations, and presentations by the Health Foundation and the Asbestos Society of WA.

We continued to provide ergonomic workstation assessments for new staff through which specific needs were identified and supported in the office environment. Field based employees continued to gain a better understanding of risk through the compulsory completion of Risk Assessments for all Gardening and Home Maintenance jobs.

Monthly OSH updates continue to provide staff and volunteers with information on relevant safety issues in the workplace, safety and wellbeing tips, resources and, most

incidents that may pose a health risk if they are exposed to body products such as blood or vomit.

All first aid kits in vehicles, in the depots and offices have also been upgraded. VTF's ongoing commitment to Safety ensures teams are motivated, energised, fit and healthy by providing a workplace that supports a healthy lifestyle and safe work practices.

importantly, awareness of identified risks and hazards.

In October VTF participated in Safe Work Australia week activities with each Gardening depot choosing their own topic to present. Themes included First Aid in the Workplace, Hand and Power Tool Safety and Fire Safety.

This year several activities were held promoting health and wellbeing in the workplace. Odd Socks Day on 3 October 2014 raised awareness of the stigma associated

with mental illness. Attitudes can cause people to disengage and deny symptoms or illness which then impacts on their decisions to seek help.

This event was a light-hearted approach to remind people that anyone can have an odd day. The key message is 'The way you treat a person does make a difference.'

Stress Down Day on 1 August 2014 highlighted stress as being a major factor affecting the physical and mental health of Australians. The goals of the day were to have fun, stress less and feel better. It was a great way to raise awareness to staff and volunteers of the Employment Assistance Counselling Program and to provide information and resources to assist people to better manage their stress.

VTF supported R U Okay Day on 11 September an event that encouraged all staff and volunteers to look out for one another and ask "are you ok?" to create a culture and environment where people feel confident asking and answering this most important question.

VTF strongly believes in the importance of the role of our Safety and Health Reps (SHRep). SHReps have an integral role representing staff and volunteers in their area, informing them on work health and safety issues and providing a means for those staff and volunteers to raise safety issues within their areas. During the year SHReps meet quarterly and play an active role in OSH communications. VTF would like to thank all the Safety and Health Representatives for their commitment and hard work during the year.

KRA 3 Build partnerships and profile

VTF was successful in receiving a community grant from the Council of the Aging (COTA WA) to hold a Seniors' Event in October in Pinjarra. The VTF Exercise, Socialise and *Revitalise* event featured an exciting day of activity sessions from our successful STEPs program. A range of our class facilitators and instructors came along for the day to provide information on our STEP classes. The Volunteer Services team were also present to explain about the range of services that VTF provides as well as volunteering opportunities that were available. Although the wet weather may have kept a few people away there was nevertheless a lot of interest in our services, in particular our Water Wise program.



FACT BOX: In 2014/15 VTF received over 38,100 hours of gardening services from our volunteers. That equates to more than \$1.48 million dollars in labour. We are very grateful to all of our volunteers for their generous support. It was also a great opportunity to meet and introduce VTF to the people of the area.

Group Volunteering experienced another year of strong participation and we are extremely grateful to our corporate friends who gave up their time to assist us in the delivery of services. KRA 4 Maintain financial independence and healthy governance

Healthy Governance for VTF has been a focus since its inception. With the growth of the organisation about to tip it over to a \$10million plus entity, the emphasis on strong, transparent, robust governance measures has never been more important. As always the Board, staff and management were involved in planning days which reinforced Volunteer Task Force's commitment to each and every staff member being engaged in our vision of excellence in enhancing independence, inclusion and quality of life for people and their communities.

The VTF Board has shown signs of strength and character this year with self-analysis leading to a change in meeting structure and the further development of the Board Subcommittees has led to greater depth of understanding, efficiencies and clarity of governance processes and responsibility. The addition of two new Directors with skill sets in law and finance has given the Board increased expertise and has insured further succession planning.

We have assessed our position and reviewed our strategic planning. With the reforms in the sector and changes afoot in the short term, the Board and Management Team decided to work on a new strategic plan with a five year horizon and this was supported with the skills and knowledge of Step Beyond consultancy.

During the year changes to the management team has seen the successful recruitment of Kath Snell (previously Senior Manager) to the role of CEO. This triggered an internal change to ensure the skills of the team complimented those of the new CEO and created the opportunity for our Manager of Operations and Projects to move into the Senior Manager role with the role now encompassing IT, business development, Volunteering and workforce operations. This team is supported by four further management positions which focus on Client Services, Support Services and Finance Management. The new team is now well balanced with each position motivated to ensure the organisation is ready for the future.

With a skilled, professional management team firmly in place, a devoted and committed workforce and a forward-looking Board the organisation finished the year on a flourishing 96% achievement of HACC target and an optimistic growth funding application submitted to the Department of Health for 2015/2016.

In our ongoing endeavours to maintain financial independence we have commenced conversations with partners that will allow VTF services to be utilised by a broader section of the community, whilst ensuring that our focus still remains on our core target group. Initial work with Carepoint and the National Disability Insurance Scheme (NDIS) has allowed us the privilege to provide some of our services to disadvantaged groups outside of HACC.

Conversations with agencies and organisations have set us in good stead for future collaborations, for potential geographical spread through the metropolitan area and beyond and for partnering for mutual benefit. The relationship with PCYC as an introduction from Town Of Victoria Park has proved to be a successful one. We very much look forward to the shared facility in Midland, allowing us greater and more efficient coverage of the

East and giving both organisations a more cost effective base in Midland.

As an organisation committed to quality services and continuous improvement we are always flattered when we get feedback that endorses our progress. For VTF this meant a visit this year by the Quality Review team from Community West as part of our HACC contractual obligations.

The reviewers found that VTF met 18 out of 18 expected outcomes of the Community Care Common Standards. The findings were that compliance processes and VTF-specific training and information requirements were set in place and that staff, including volunteers, benefited from a system of appropriate induction, training and performance appraisal to promote the safe delivery of services. An external program of research and evaluation by Curtin University indicated a commitment to continuous improvement. The successful Quality Review result, supported by successful HACC Growth Funding applications, has enabled VTF to expand and enhance services, and is an endorsement of the work VTF does to ensure that policies are live, active documents that enable staff to be continuously updated on new initiatives and our quality expectations.
